Status of various Central Schemes being monitored by the Prime Minister's Office:- It is submitted that Student Police Cadet program (a Centre & State Govt. share basis scheme) has not yet been implemented, as the action plan of this scheme is yet to be approved by the State Govt., which is under consideration with Govt. of H.P. However, the actions/initiatives taken for the implementation of SPC program, is as under:-

- i) Constitution of Committees:-The State Level Monitoring Committee headed by the Additional Chief Secretary (Home) to the Govt. of H.P has been constituted to lay out broad policy objectives and operational guidelines, which will also monitor the progress of the programme. The Steering Committees at District Level have also been constituted in all the districts under the chairmanship of Dy. Commissioners of respective districts.
- **ii)** Nodal Officers at District level:-All district SsP have nominated Nodal Officers, to coordinate and liaise with the schools and other relevant stakeholders for implementing the Programme in their respective districts.
- **iii)** Nodal Officer at State level:-Sh. Himanshu Misra, IPS, IGP/AP&T has been nominated as the Nodal Officer of Student Police Cadet Program.
- iv) Schools: 60 schools @ 5 in each district have been identified.
- v) Funding:-Funds to the tune of Rs. 43.88 Lacs have been allotted to the State under the Modernization of Police Forces scheme for implementation of the Student Police Cadet Programme, which are subject to the sharing pattern between Centre and States applicable to the MPF scheme.
- **vi) Training:**-Five master trainers have been trained by the BPR&D for the purpose. Total 110 police trainers have been trained by the master trainers.

- 4) Student Police Cadet Programme :- MHA, GOI has released funds of Rs. 43.88 lakhs for the project which emphasizes to develop better quality in the students to become a responsible citizen and to educate them with regard to crime in such ages. The funds were released in 2016-17 and 2017-18. MHA, GOI has revised the guidelines for its implementation in March, 2018. Earlier the funds for Central Schools, Navodaya Vidyalaya and Tibetian Schools was to be spent first. Total 60 schools including all Central schools, Navodya Vidyalaya and Tibetian School were to be included from HP i.e. @ 5 per districts. As per revised guidelines, the funds are to be spent for Govt. schools and the Committee at State Level and District Levels are to be constituted. The action plan has been endorsed by the L&O Branch to Govt. vide letter No. L&O -11-20/ Student Police Cadet/2018-8892 dated 22-4-2018 for further approval/consideration.
- 5) Assistance to States &UTs for Narcotic Control: During the year 2017-18 an amount of Rs. 14.00 lakhs has been provided by the Govt. of India. These funds have been sought from the state Govt. Out of this an amount of Rs. 3.80 lakhs has been provided by the state Govt. for equipments. The proposal for purchase of vehicle (LMV-1, M/Cycle-6) is under consideration with the state Govt.
